I have accurately represented the above listed information and it is true and correct. I accept for use "as is" the equipment listed on this form, and accept full financial responsibility for the care of the equipment while it is in my possession. I will be responsible for the replacement at full value of any equipment rented under this from, but not returned to the rental facility. I agree to return all rental equipment by the agreed date. Any lost or stolen equipment shall be replaced or compensated for by the customer. I understand that the binding system cannot guarantee the users safety. In downhill skiing, the binding system will not release at all times. For snow-boarding, cross-country, skiing, ski boarding, snowshoeing and other sports utilizing equipment with non-release bindings, the binding system will not ordinarily release during use; these bindings are not designed to release as a result of forces generated during ordinary operation.

I understand that the sports of skiing, snowboarding, snowshoeing and other sports (collectively "RECREATIONAL SNOW SPORTS") involve inherent and other risks of injury and death. I voluntarily agree to **expressly assume** all risks of injury or death that may result from these RECREATIONAL SNOW SPORTS, or which relate in any way to the use of this equipment. I understand that a helmet designed for RECREATIONAL SNOW SPORTS use will help reduce the risk of some types of injuries to the user. I recognize that serious injury or death can result from both low and high energy impacts, even when a helmet is worn.

In consideration of allowing me to rent equipment from Lookout Pass Associate, LLC, d/b/a Lookout Pass Ski & Recreation Area ("Lookout"), I agree to RELEASE Lookout from any and all liability and/or claims for property damage, injury or death arising from my participation in RECREATIONAL SNOW SPORTS, including those claims based on Lookout's alleged or actual NEGLIGENCE. Further, I agree to WAIVE my right to file a lawsuit against Lookout for **any existing or future claims**. Additionally, I agree to DEFEND and INDEMNIFY Lookout from all claims for property damage, injury or death arising out of my participation in RECREATIONAL SNOW SPORTS, which (1) I may suffer or for which (2) I may be liable to others or for (3) my conduct that may contribute to a claim being asserted against Lookout.
